**SECOND AMENDMENT TO  
ARTICLES OF INCORPORATION  
OF  
MISSOULA FIGURE SKATING CLUB, INC**

Article VI is hereby amended to read as follows:

**ARTICLE VI.**

All of the funds and assets of the corporation, together with the net earnings thereof and income realized thereon, shall be exclusively devoted to the pleasure, recreational and other non-profitable objects and purposes set forth in these Articles. No member, trustee, director, officer or employee of the corporation or any other person shall receive or be entitled to receive, under any circumstances, any part of the net earnings of the corporation or any pecuniary profit from the operation thereof, except as reasonable compensation for services rendered in effecting one or more of the purposes of the corporation.

- a. Dissolution. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

These amendments to the Articles of Incorporation are executed by the Vice President, Ryan Yearous in his capacity as the Vice President of the corporation and chairman of the meeting of the Board of Directors held on September 1, 2009.
