#### REFUND POLICY

Costume fees are non-refundable. You may request a **partial refund** for your Performance Fee(s) up to and including the first practice. There are no refunds\* after the first practice for your group number(s). All refunds will reflect the following deductions:

- MFSC Administrative Fee - \$10
- Cost for one practice (if applicable) - \$12.50

\* If a skater is unable to complete the Showcase on Ice practices and/or performance due to injury, the skater may submit a written request to the Show Director to make an exception to the above refund policy. To be considered, all refund requests must be received within 10 days of the Show for which you are requesting a refund.
