Champions is open to those who have passed **the Pre-Preliminary or Adult Bronze Moves in the Field test**. The group levels will be split among two coaches depending on subject matter. See chart below for general guidelines:



Champions Skating School is intended for the highest level skaters in MFSC. Skaters will spend an intense 45 minutes in separate groups (see above) working on edges, single and double jumps, all types of spins, power skating drills, footwork sequences, artistry, and ice dancing. "Champions" will be a challenging, concentrated workout and will provide skaters with the fundamental tools for putting together an effective skating performance. The size of the class may be limited.

SESSION I: October 10 – December 5, 2010 (8 classes) – **NO class November 28th**

Days & Time: Sundays, 5:00-5:45pm

Cost: \$175 for class participants who are first time MFSC members* (includes membership, ice time & coaching)

\$125 for class participants who are current or previous MFSC members* (includes ice time & coaching)

Policies: Classes will not be offered on a drop-in or prorated basis. Enrollment may be limited.
